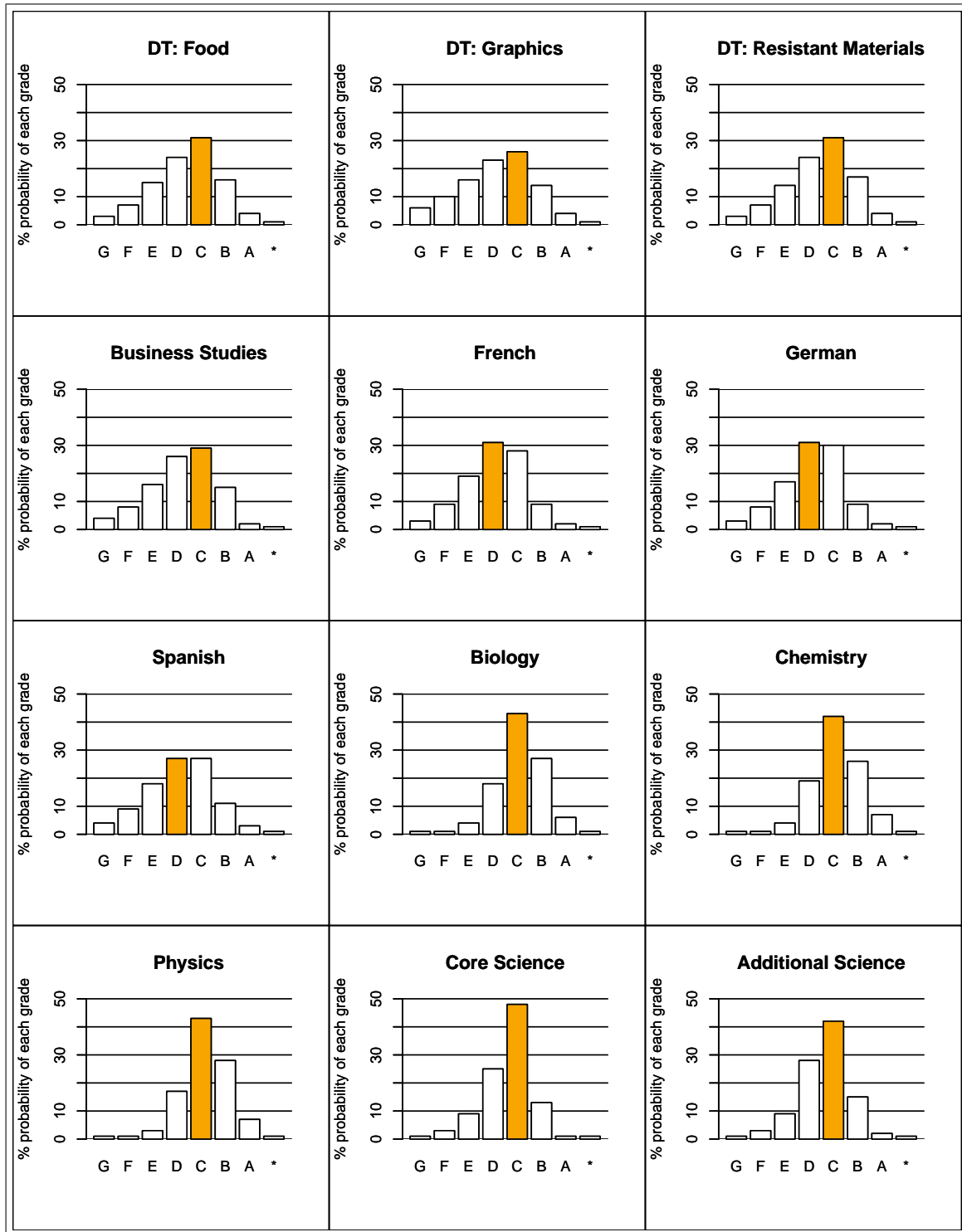


FFT type D GCSE estimates for Benjamin Barker, 11A 12 main subject groups

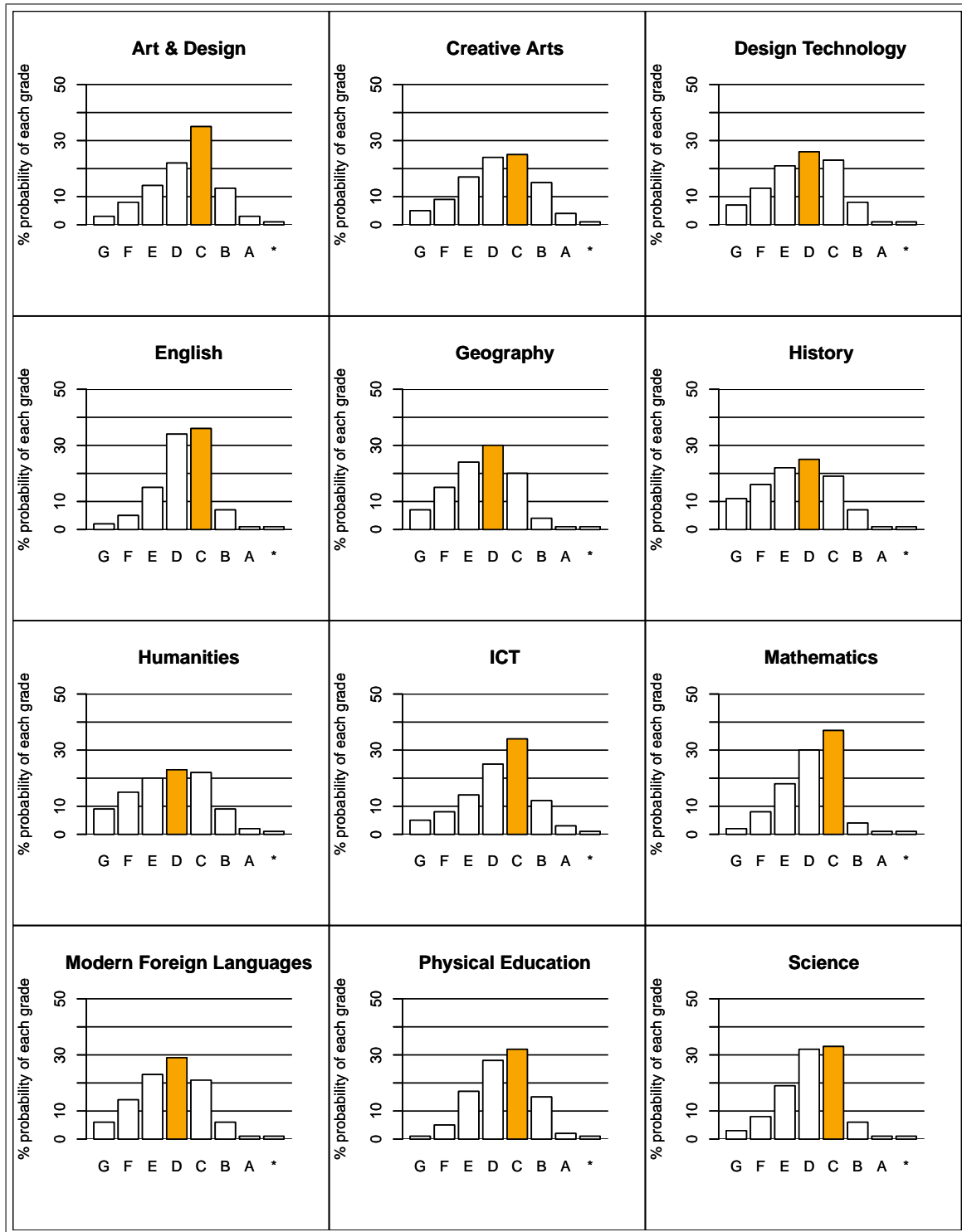

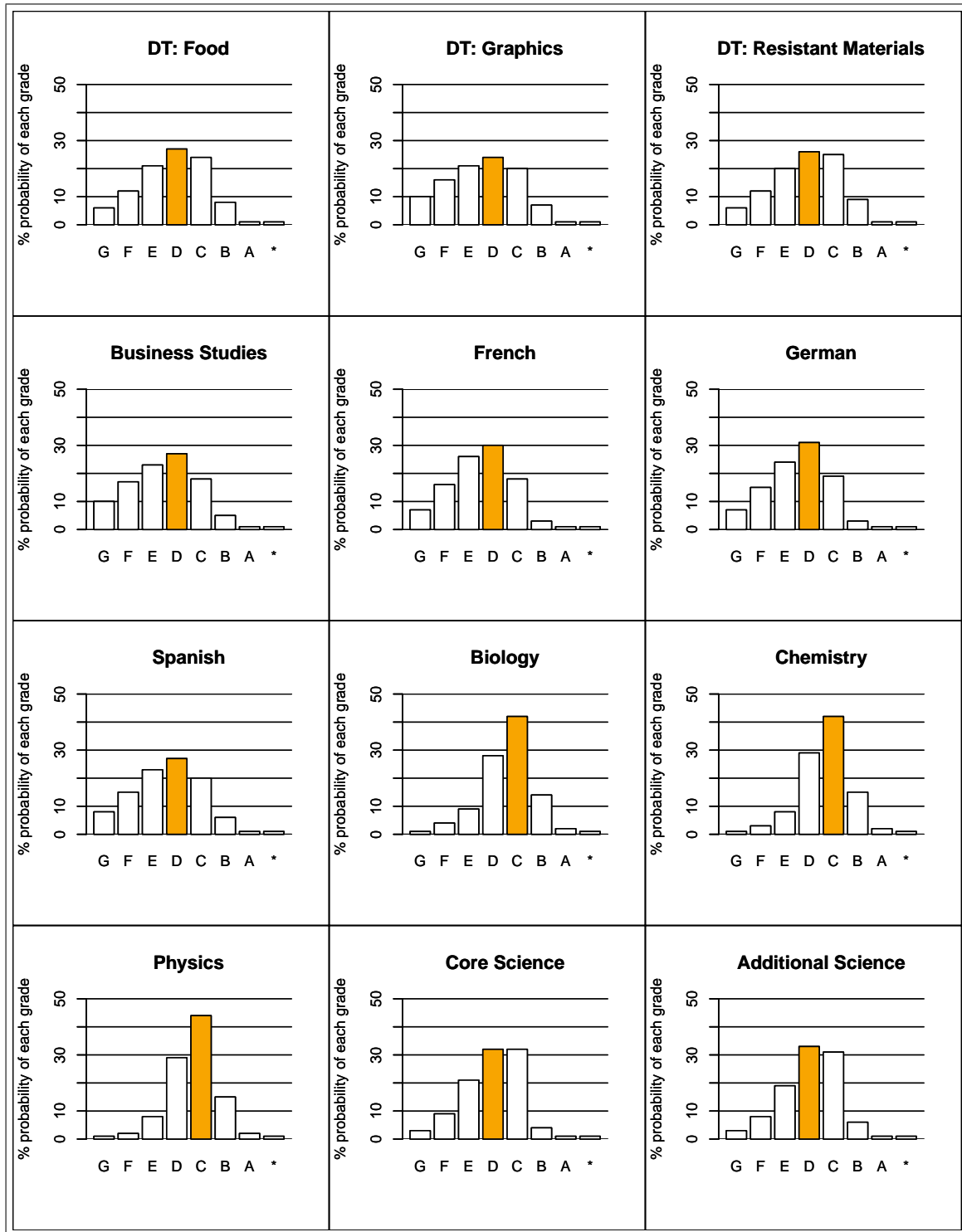


FFT type D GCSE estimates for Edward Bennett, 11A 12 main subject groups



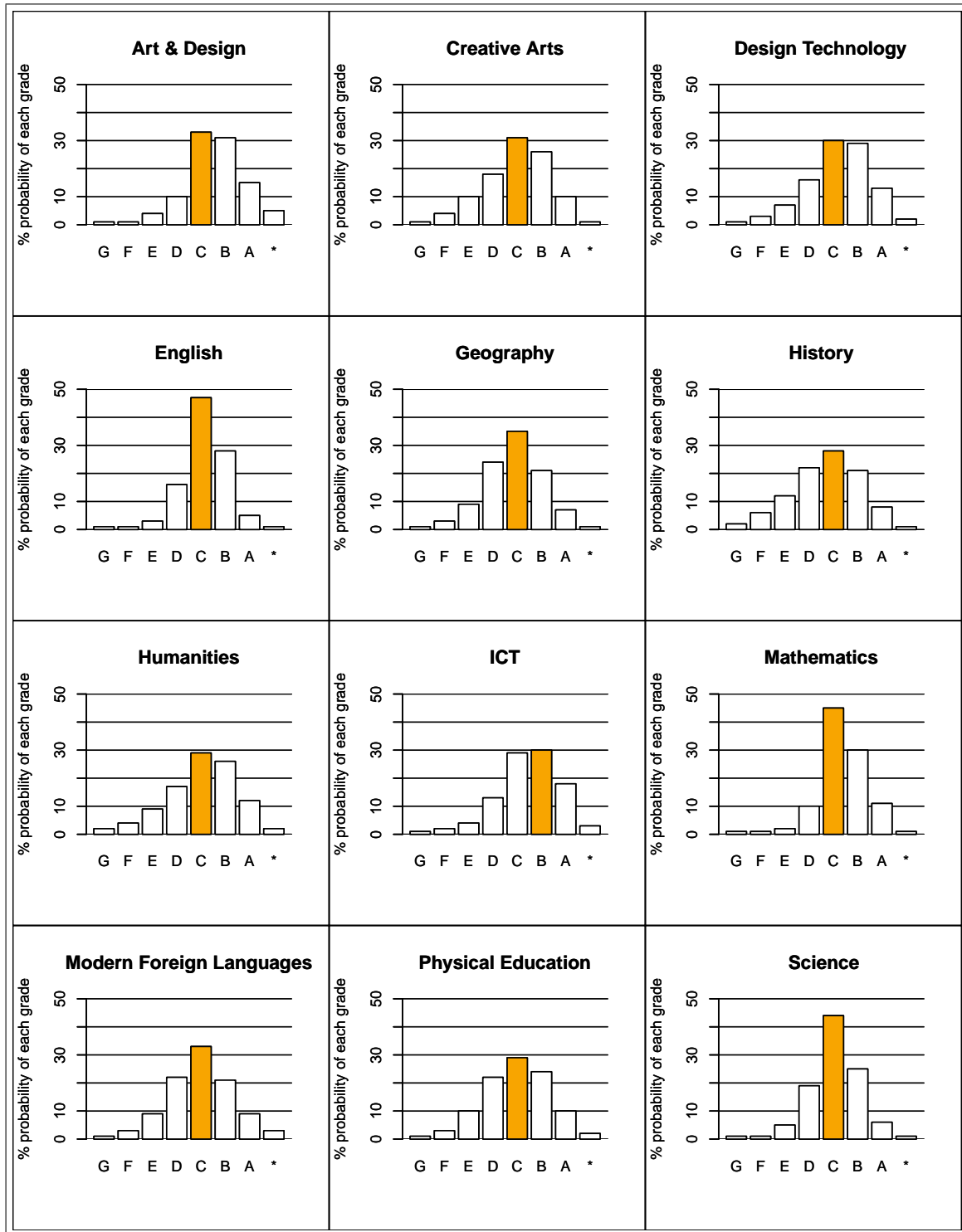

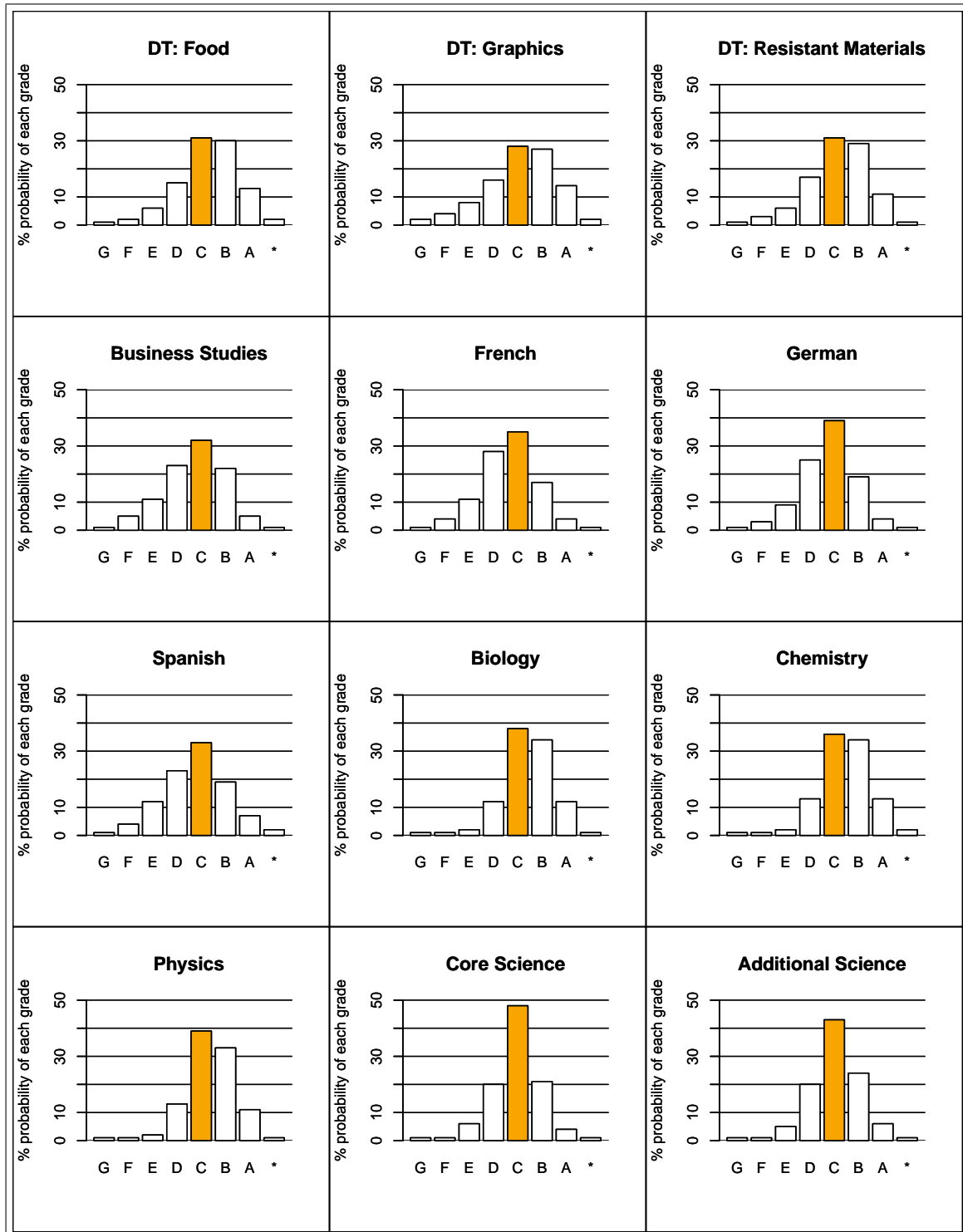

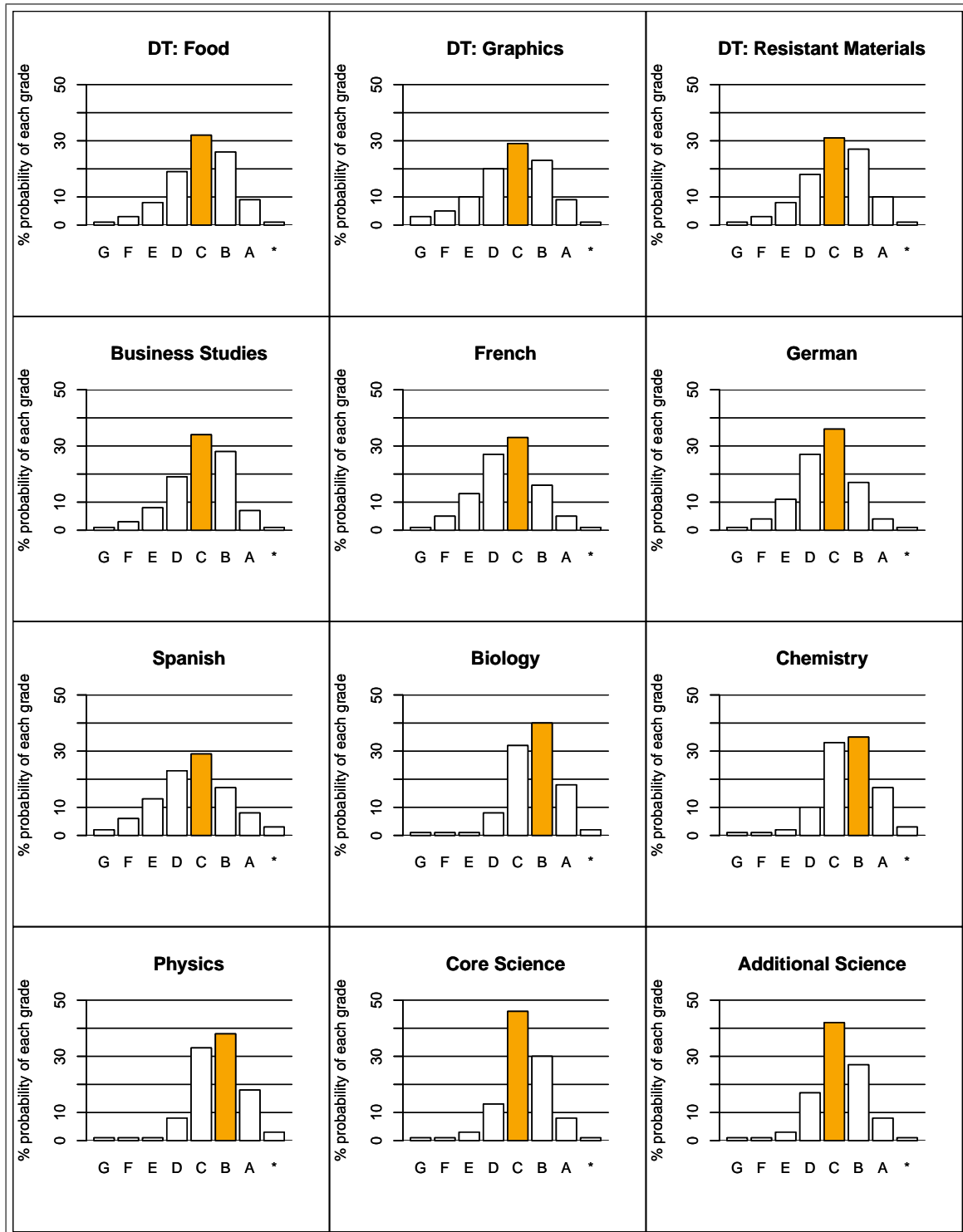

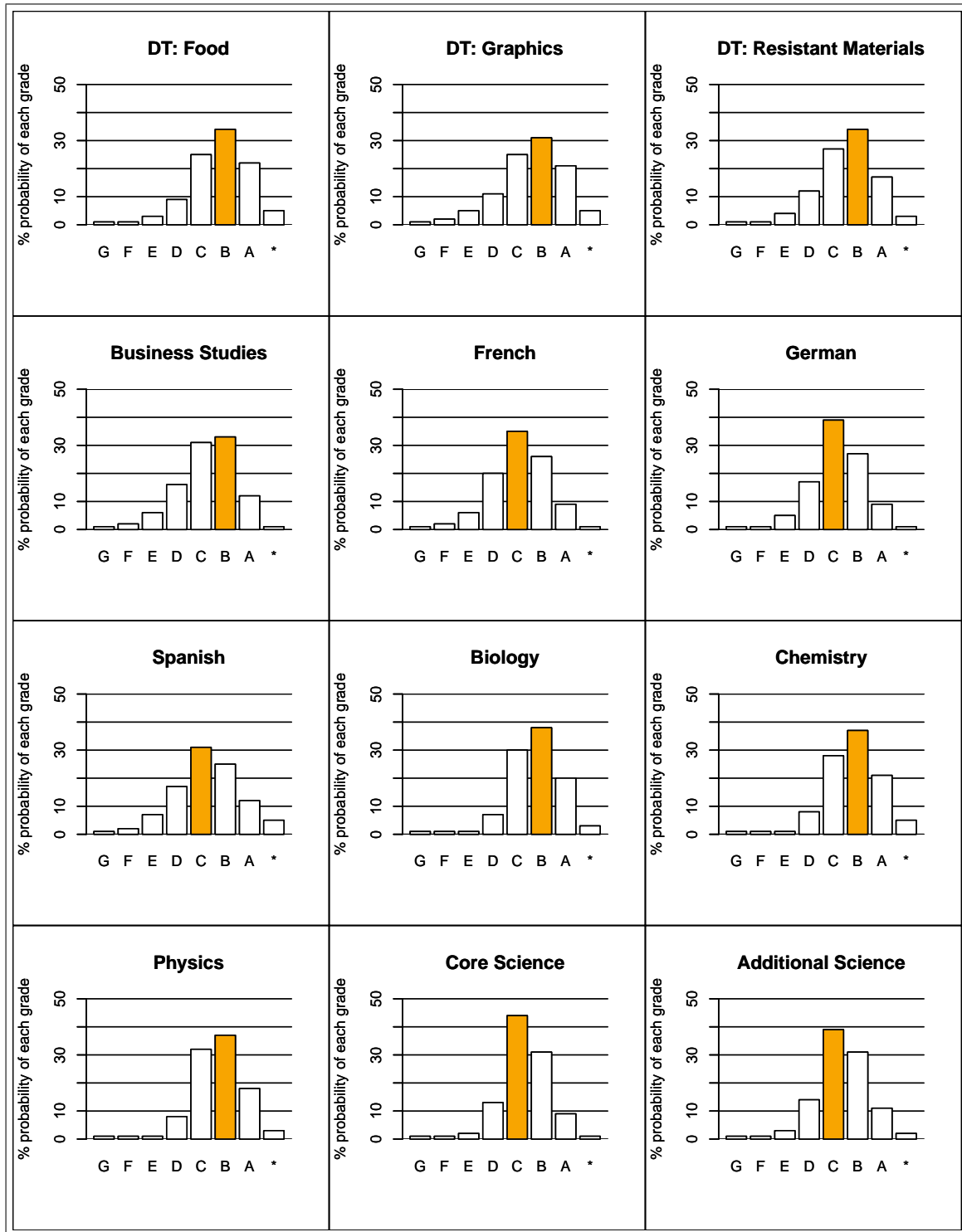

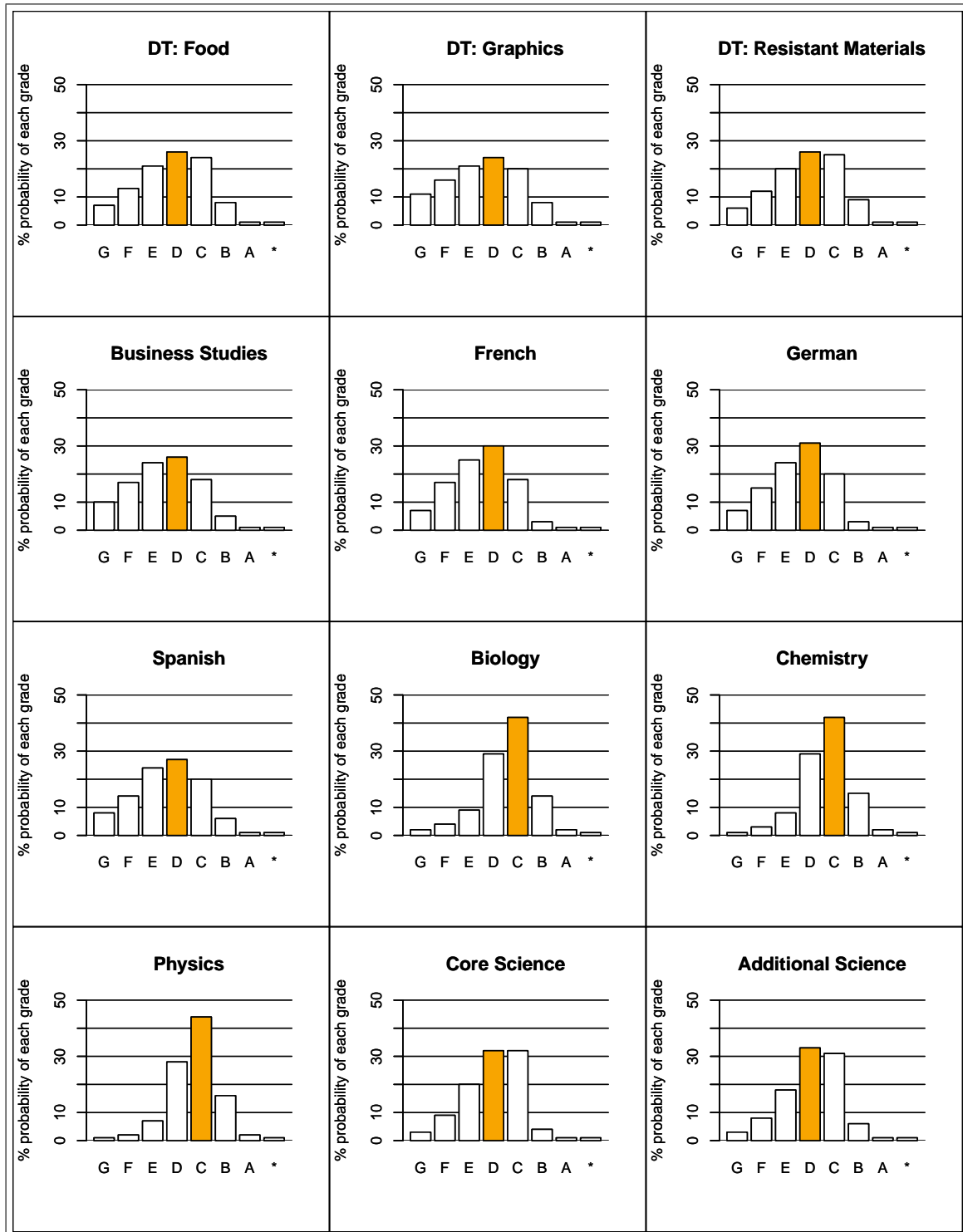


FFT type D GCSE estimates for Jayden Lane, 11A 12 main subject groups



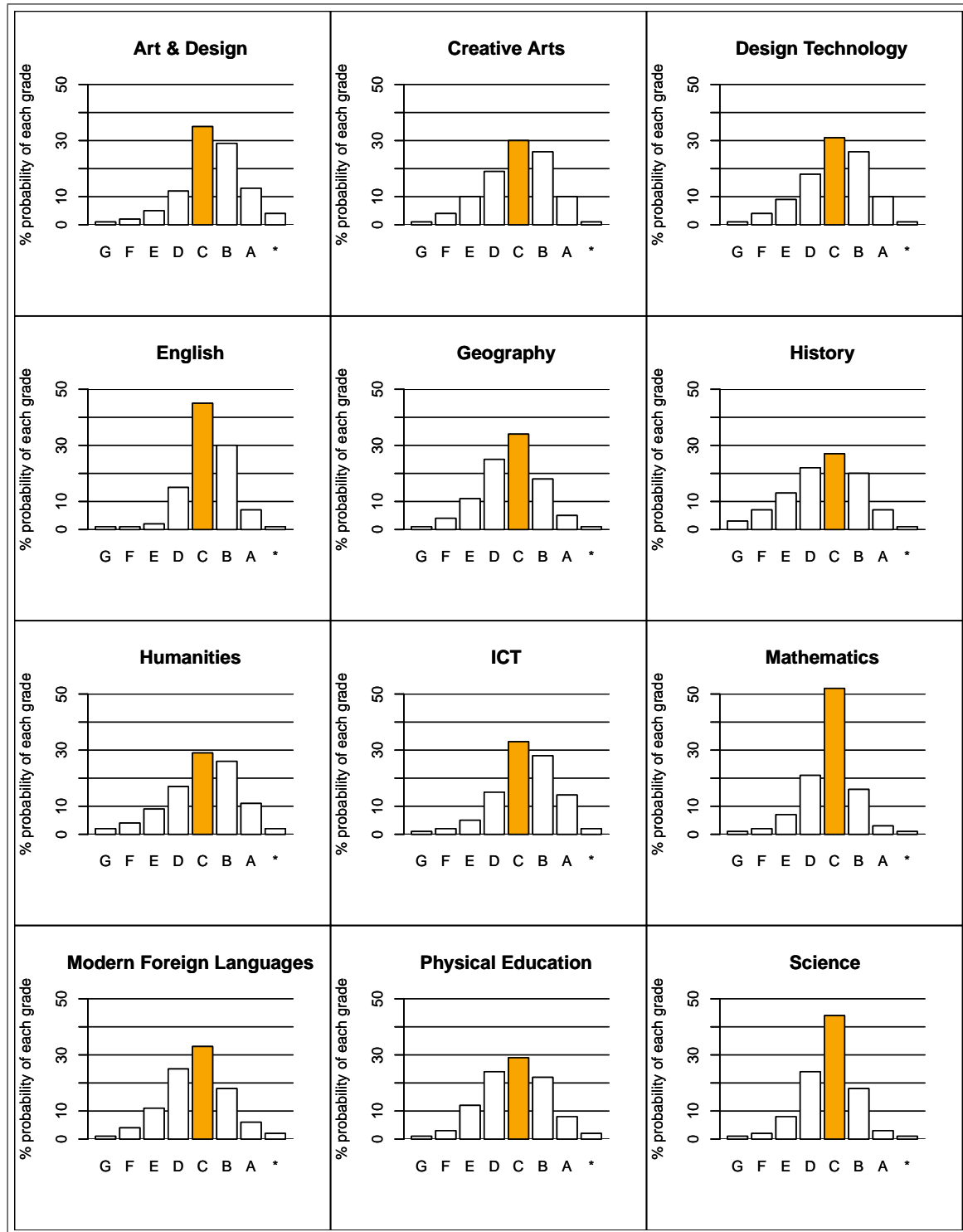

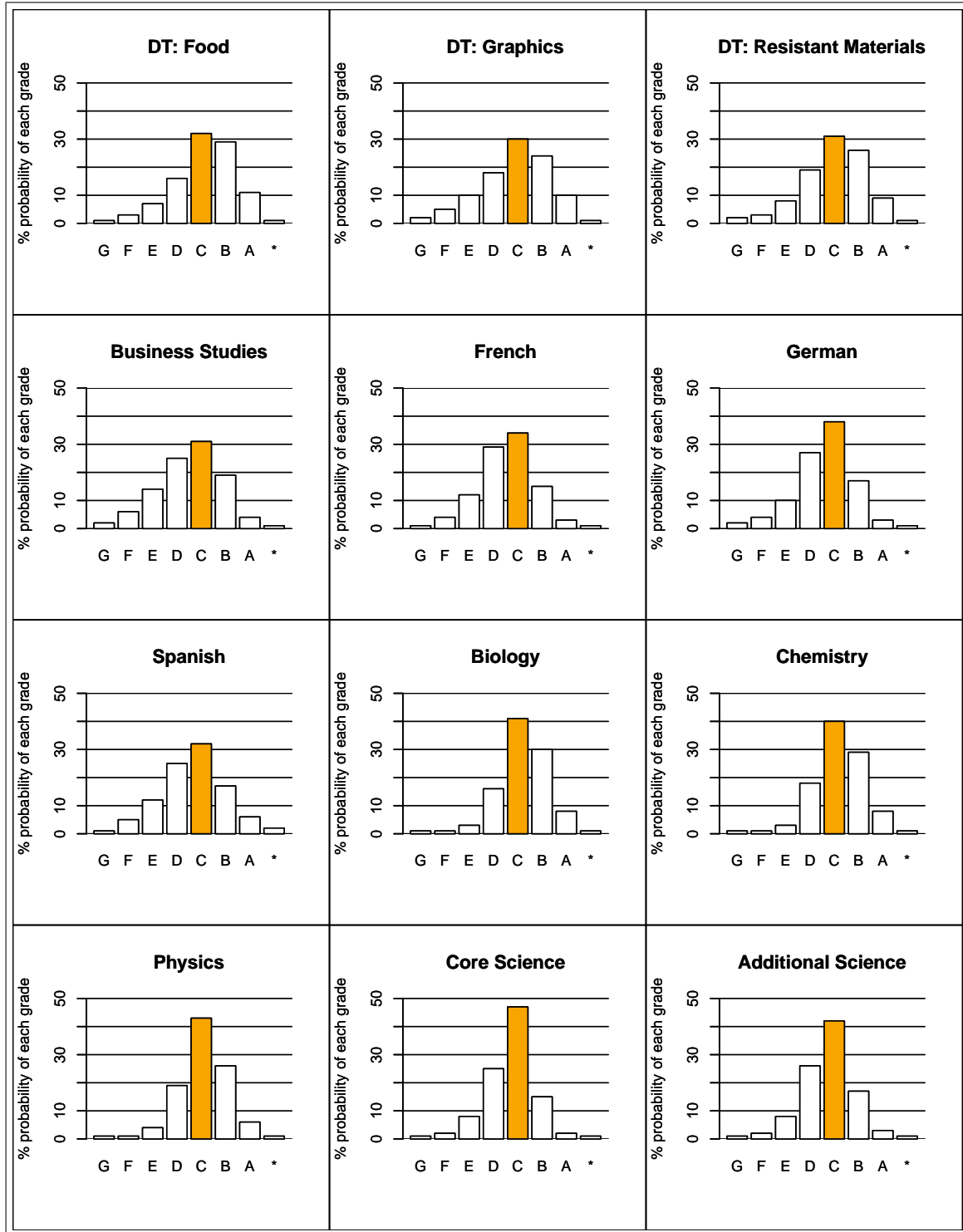

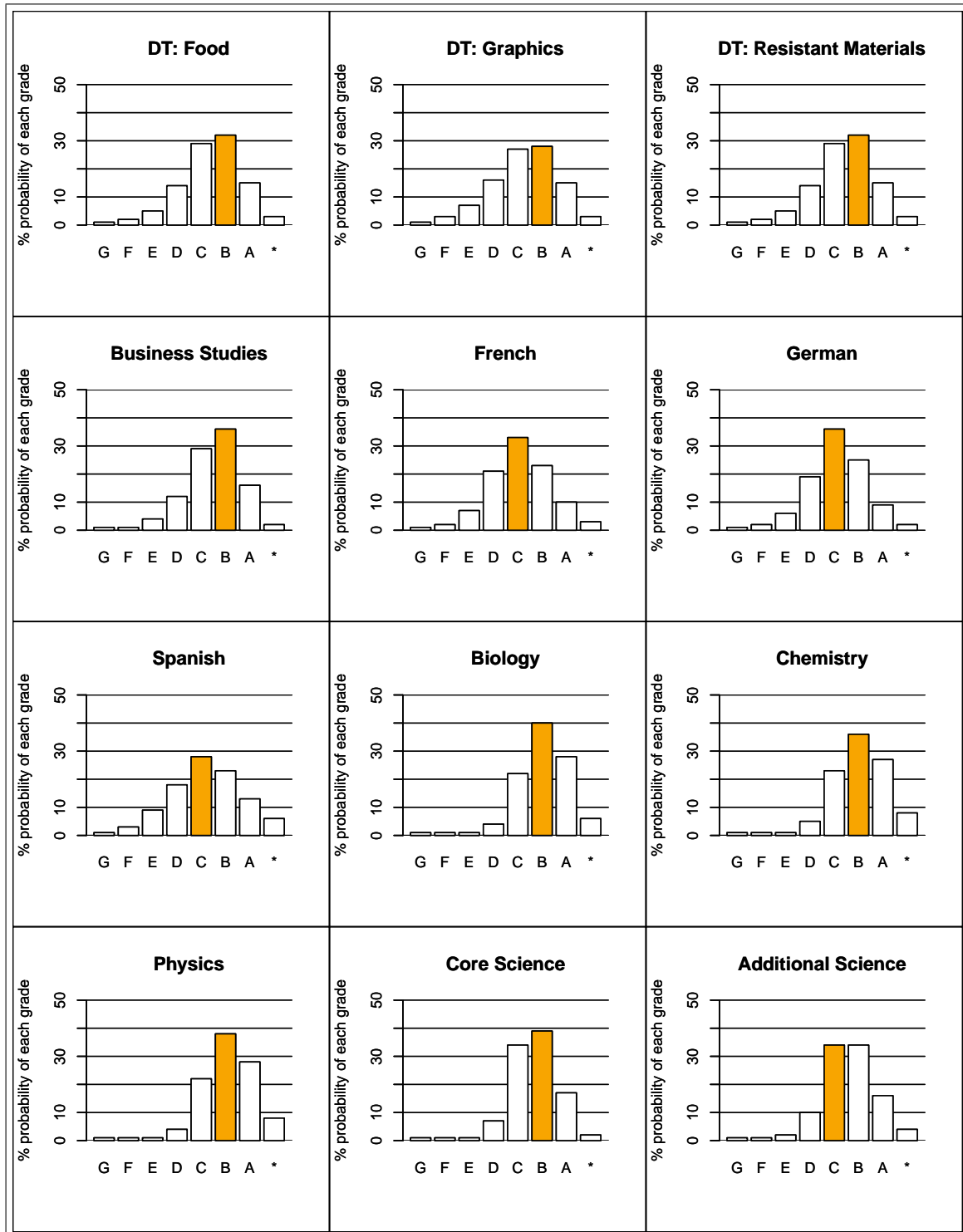
